

Episode 50SC™

TO CAUSE A HAZARD IN THE USE, STORAGE OR DISPOSAL OF THIS SUBSTANCE IS AN OFFENCE.

PRECAUTIONS:

1. Handle with care. Harmful when swallowed. Avoid contact. Dangerous when inhaled.
2. Store away from sun and damp conditions.
3. Store in the original closed container in a cool, dry and well-ventilated place UNDER LOCK AND KEY.
4. **KEEP APART FROM FOOD AND FOODSTUFFS, SEEDS AND FERTILIZERS.**
5. **KEEP OUT OF REACH OF CHILDREN, UNAUTHORIZED PERSONS AND ANIMALS.**
6. Wear protective clothing e.g. overall, rubber gloves, nose covers and gumboots when handling, preparing and applying the spray mixture.
7. Avoid prolonged or repeated exposure.
8. DO NOT carry Episode 50SC™ in a vehicle which is used to carry people.
9. Toxic to aquatic organisms.
10. Wash contaminated clothing after use.
11. Wash with soap and water after use or after accidental skin contact.
12. Avoid eye and skin contact and inhalation of spray mist.
13. Do not eat, drink or smoke while mixing, applying or before washing hands and face or change of clothing.
14. DO NOT contaminate streams, rivers or waterways with the chemical or used containers.
15. Clean application equipment after use. Do not dispose of water where it can contaminate other crops, grazing, rivers or dams, feedstuffs, drinking water and eating utensils.

CONTAINER DISPOSAL: Triple-rinse empty packaging before disposal. Add rinsate to the mixing tank. DO NOT dispose of undiluted chemicals on-site. Dispose of at a local authority landfill. If no landfill is available, bury the container below 50 cm in a disposal pit specifically marked and set up for this purpose, which should be away from waterways, desirable vegetation and tree roots, and in line with local regulations. Empty packaging and product should not be burnt. Do not re-use the empty packaging for any other purpose.

DEALING WITH SPILT PRODUCT: Spilt product must be absorbed in sawdust or sand and collected using a broom and dustpan (without a touch of the hands). A spilt product, an expired product or a product spoiled during storage is a hazardous waste and must be disposed of at the toxic waste site.

SYMPTOMS OF POISONING: This product may be harmful if swallowed, inhaled or absorbed through the skin. May cause skin and eye irritation.

FIRST AID INSTRUCTIONS:

Eyes: Hold eye open and rinse slowly and gently for 15-20 minutes with clean water. Obtain medical advice if irritation persists.

Skin: Take off contaminated clothing. Rinse skin immediately with plenty of water and soap for 15-20 minutes.

Ingestion: Have patient drink plenty of water if able to swallow. DO NOT induce vomiting unless if told to do so by a medical practitioner. Keep patient at rest. Do not give anything by mouth to an unconscious person.

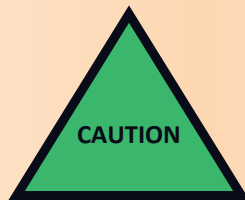

Description:

Episode 50SC™ is a suspension concentrate, contact and stomach insecticide for the control of Thrips, Caterpillars and Caterpillars on a wide range of crops.
 - Spinosad is a natural product obtained from the soil bacteria Saccharopolyspora spinosa. Spinosad is highly active, by both contact and ingestion. Episode 50SC™ has a novel mode of action, primarily targeting binding sites on nicotinic acetylcholine receptors (nAChRs) of the insect nervous system that are distinct from those at which other insecticides have their activity.
 - Spinosad IRAC Group: 5 (Nicotinic acetylcholine receptor (nAChR) allosteric modulators – Site I).
 - Always alternate with insecticides with different mode of action through the season to prevent the development of resistant pests.

Instruction for Use:

Fill 1/3 of the tank with clean water and add the required amount of the product. Ensure adequate agitation during filling, mixing and spraying.

DIRECTIONS FOR USE: Episode 50SC™ should be mixed with water to be ready for use. It may be applied with any type of spraying equipment.

* Use 300 ml of the spray mixture per tree to treat part of the canopy

Important Notes (bait application)

- Droplet size: 4 – 6 mm
- Always use the spray mixture within 12 hour from preparation
- Proper timing of application: From the core coagulation according with the monitoring results (adult captures)
- Choose trees of proper development
- In sparse orchards spray every tree (part of the canopy)
- In dense orchards, spray every 2nd or 3rd tree (part of the canopy)
